## **Tax Bill Text/Email Notification Program Instructions**

Welcome! This tutorial will aid you in the steps necessary to complete to signing up for, changing for, or unsubscribing from the Ozaukee County Text Message/Email Notification Program. With this program, you are able to receive notifications on certain events pertaining to property taxes. This is a **FREE** service to you (Data and messaging rates may apply. Check with your device provider.) There are 4 types of messages you can opt to receive:

1. Tax Bill Available.
  - This will notify you when your tax bill is published on the website located at: <https://www.ascent.co.ozaukee.wi.us/LandRecords/>
2. Tax Bill Payment Received.
  - This will notify you after 24 hours of a payment received within the Ascent Land Records Suite. This is very beneficial to those of you who have an escrow pay your tax directly.
3. Tax Bill Installment Payment Due.
  - This will notify you of a full payment or installment payment due to 10-20 days before the due date.
4. Taxes are Delinquent.
  - This will notify you a tax bill becoming delinquent 24 hours after it is marked delinquent.

# Sign-Up for Tax Bill Text/Email Notification Program Instructions(cont.)

Signing up is fast, secure, and free!

1. Go to: <https://ascent.co.ozaukee.wi.us/AscentNotifications/index.html>
2. Enter your first and last name.
3. Enter your cell phone number (no dashes).
4. Enter your email address
5. Click “Subscribe”.

You will then be asked to agree to receive a security code and agree to signing up by entering in that code sent to your cellular device as a text message or directly to your email as a confirmation email. (Hint: If you do opt for having it sent to email and do not see it, please check your spam folder).
  - **IF YOU CHOOSE TO RECEIVE YOUR VERIFICATION THROUGH TEXT MESSAGE DIRECTLY TO YOUR CELLULAR DEVICE, THE CODE WILL COME FROM PHONE NUMBER 262-714-7496**
  - NOTE: If the confirmation is sent to your email, you will be brought back to the home screen. Check your email, open the confirmation email and click “Confirm” to be brought to the homepage to log in again.

8. On the next screen, enter your first and last name OR your site address OR your parcel number.
  - If you are searching by parcel number, please DO NOT use dashes or dots.
  - NOTE: For Owners of Multiple Parcels, use your name to locate all parcels owned by you. The ownership name must be THE SAME per parcel. Please make sure your mailing address is the SAME for all parcels as well.
